O R D E R

As per the Government Order read as 2nd paper above Government ordered that the community "Chetty" having the sub castes names within brackets alone be treated as O.B.Cs. By this order those whose caste mentioned in the school certificat as "Chetty" alone without mentioning any sub castes are not bring given the benefit of Other Backward Classes.

The Kollam Chetty Sabha and several organisations of Chetty Community requested Government to reconsider the above Government order requesting to restore the reservation benefits enjoyed by them for nearly half a century and subsequently denied.

Government have examined the case in detail and have observed that as per the proceeding order read as 1st paper above it was ordered that -

"Government are pleased to order that "Chetties" will be included in the list of 'Other Backward Communities' for the grant of educational concessions and under 'Backward Classes-other Hindus' for reservation of appointment in Public Service under Article 16(4) of the Constitution".

In the above circumstances, Government are pleased to order that "Chetties"/"Chetty", including the subcastes names within brackets mentioned in the State list of Other Backward Classes, will be treated as Other Backward Class.

The Government Order read as 2nd paper above stands cancelled.
