ORDER

In the representation submitted to the Kerala State Commission for Backward Classes, Sri.E.D.Gopalakrishnan, President, Wayanad Sree Vyshnava Samajam has stated that the Vyshnava Gowder Community are socially, educationally & economically backward and they do not have proper representation in Government Service. The Wayanad Sree Vyshnava Samajam has requested to include Vyshnava Gowder Community in the list of Other Backward Classes in the state of Kerala,

The Kerala State Commission for Backward Classes has examined the matter based on the report of the KIRFADS and in the light of the criteria fixed for including a particular Community in the state list of Other Backward Classes. Two opportunities were given by the Commission to the petitioners to produce documents in support of their claim but no evidence were produced.

After an extensive study of the complainant's Social, Educational and Economical status, the KIRFADS reported that they do not suffer from any social backwardness by their vocation or profession. Therefore the Commission has unanimously come to the conclusion that the request of the Wayanad Sree Vyshnava Samajam to include Vyshnava Gowder Community in the State list of Other Backward Classes cannot be acceded to and has advised Government that the Vyshnava Gowder Community need not be included in the state list of Other Backward Classes. Normally the advice of the Commission shall be binding upon Government

Government are pleased to accept the advice tendered by the Kerala State Commission for Backward Classes contained in the report forwarded along with the letter read as 2nd paper above and order that the 'Vyshnava Gowder Community' need not be included in the State List of Other Backward Classes.
