O R D E R

In a representation preferred by the Secretary, Parivara Bant Sangh, Kasargod to the Chief Minister with a copy to the Kerala State Commission for Backward Classes requesting that the Parivara Bant Community be included in the existing State List of OBC for the purpose of reservation in Public Services.

2. The Parivar Bant Community which has 'Tulu' as the mother tongue is a very small community to the northern areas of the district in the segment north of Chandragiri Rivers including Adoor Village of Kasargod Taluk. They are socially, educationally and economically backward. The members of the community are agricultural labourers and pettyfarmers.

3. The aspects of the backwardness of the community came up for considerations much earlier than Indian Independence and as early as in 1930s. Under the Madras Presidency, Primary and Secondary Education were partly within the control of the District Boards as early as 1935. Considering the Backwardness of the community the District Administration gave some incentive encouraging the Children of this community to get educational facilities in Primary and Secondary Schools. The educational

concession extended to the community was continued by the Govt. of Kerala also. The community was thus included as one of the communities of Malabar Area eligible for educational concession. From these facts the backwardness of the community can be seen to be accepted and recognised by the Govt. of Kerala also, they claimed.

4. The Petitioners prayed that the Parivar Bant Community may be included in the list of O.B.C. The Kerala State Backward Classes Commission have examined the request on the basis of criteria for identifying the backward Classes.

5. The allegations and evidence of Parivara Bant Sangh, Kasargod are taken into consideration in the light of the principles laid down in the constitution of India and various observations of the Hon'ble Supreme Court of India. The Commission is of the unanimous opinion that the petitioners utterly failed in establishing the fact that they belonged or belong to a socially backward class.

Therefore, the commission has advised Govt. under section 9(1) of the KSCBC Act 1993 (Act 11 of 93) that the Parivara Bant Sangh, Kasargod is not entitled to be included in the list of Backward Class of citizen contemplated by Article 16 (4) of the Constitution of India. The advice of the Commission is ordinarily binding on Government.

6. In the circumstances Govt. are pleased to accept the advice tendered by the KSCBC, contained the report forwarded to Govt. along with the letter read first paper above and order that the Parivara Bant Community need not be included in the state list of CBC for reservation of jobs in Public Services.
