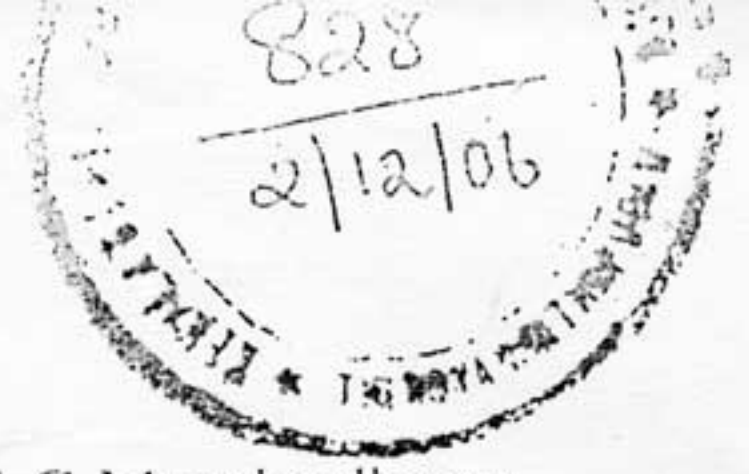

ORDER

In the representation submitted to Kerala State Commission for Backward Classes Sri.K.G.Muraleedharan, Secretary, Viswakarma Samudayam has pointed out that present conditions of Vilukurup community is such that preferential treatment in the matter of appointment is necessary as their strength in the service is too meagre. Kerala State Commission for Backward Classes has examined the request after having given two opportunities to the petitioner to produce documentary evidences in support of their claim. But no evidence or materials were produced.

They were already included in the State list of OBCs. It was on the basis of the backwardness that they are included as one of the sub classes of Viswakarma in the list of Other Backward Classes. The complaint is silent about their representations in service or their educational status. Main request is to set apart separate reservation quota. The strength of the community is the main criteria for apportioning separate reservation quota. Having regard to their present status in OBC list they may gain more educational capacity so as to secure higher rank in appointments.

The Kerala State Commission for Backward Classes has unanimously come to the conclusion that the ingredient required for qualifying for a separate quota is not forthcoming and hence the claim of the complainant cannot be acceded to and has advised Government accordingly. The advice of the commission shall ordinarily be binding upon the Government.

In the circumstances, Government are pleased to accept the advice tendered by the Kerala State Commission for Backward Classes not to set apart a separate reservation quota for Vilkurup community and orders issued accordingly.
