ORDER

In the representation read as 1st paper above, the General Secretary, Moundadan Chetty Samudaya Welfare Sangham, Wayanad has requested to include Moundadan Chetty also with other sub caste of Chetties in the State List of OBCs.

The Kerala State Commission for Backward Classes has conducted a preliminary hearing with the representatives of the community and sought the report of KIRTADS. The KIRTADS conducted a survey of the community and evaluated their social, economic & educational status and has reached the conclusion that the Moundadan Chetty satisfies the criteria prescribed for inclusion of community in the State List of OBCs in Kerala.

The Kerala State Commission for Backward Classes has examined the matter in the light of the report of KIRTADS and the criteria fixed for including a particular community in the State List of OBCs and came to the conclusion that Moundadan Chetty community satisfies the conditions for including them in the State List of OBCs.

The Commission rendered their advice to Government that the Moundandan Chetty need to be included in the State List of OBCs in Kerala State Under Article 16 (4) of the Constitution of India. The advice of the Commission shall ordinarily be binding upon the Government.

In the circumstances, Government are pleased to accept the advice tendered by the Kerala State Commission for Backward Classes recommending the inclusion of Moundadan Chetty along with other Sub-Castes (components) specified within brackets of item No.13 Chetties contained in the List III of Schedule to Part I KS&SSR 1958 and orders issued accordingly amending item No.13.
